Promotion Start Date & Time	Wednesday 1 st July 2020
Promotion End Date & Time	Wednesday 29 th July 2020
Promotion Periods	This promotion will run every Wednesday during the Promotional Period from 5pm to 7pm.
Who may enter	Only current financial members of West HQ who are over the age of 18 years (Eligible Members) may enter this promotion.
How to enter	<ol style="list-style-type: none">1. An eligible member must only swipe their OWN West HQ Loyal card at the member's promotional terminal2. An eligible member must swipe their West HQ Loyal card at the member's promotional terminal between 5pm-7pm every Wednesday during the promotional period dates to receive their one (1) ticket that entitles them to a sheet of draw tickets which they can receive from the promotional compere3. Please note that NO Tickets can be purchased, and Visitors do not receive any tickets.4. Swipe tickets must be redeemed on the day of the promotion during the promotional period times to be considered valid.5. In the event that the promotional terminals are not working, members will need to see the compere and membership names and numbers will be written down on a ticket log.
How to Play	<ol style="list-style-type: none">1. Eligible members must present their ticket to the promotional desk before the draw starts, or they tickets will become invalid and member won't be able to participate in the draw2. The draw will start at 7pm every Wednesday during the promotional period date.3. Draw tickets will be entered into a random number generator prior to the draw time.4. Promotional compere will then press the number generator to draw the first winner.5. Member will have four (4) minutes to present themselves, if member doesn't present themselves a redraw will take place.6. Member who presents themselves within the 4-minute period will select a numbered box from the minor prize section. The compere will reveal the prize amount won.7. This process will continue with each winner until all the minor prizes have been awarded.8. After all Minor prizes have been won, Promotional compere will start announcing the winners of the Mini Major prizes.9. After all Minor Major Prizes have been won, Promotional
